Byron Davies: Thank you very much, Chair. I am grateful to have the opportunity to ask for this extremely important debate. Of course, the beer industry, the pub industry, affects every single constituency and every part of the United Kingdom. That is reflected by the fact that here in Parliament we have two all-party parliamentary groups—one on beer and the other on saving the pub—and they are among the biggest groups in Parliament. There is great interest across the parties here in Parliament.

The beer and pub industry has a huge impact on the UK economy. It is worth something in the region of £23 billion in gross value added and is, of course, of massive importance to the Treasury in terms of tax take, but in particular, and more importantly, in terms of jobs and the wider UK economy through the connected supply chain.

The industry is of course vital to many and varied aspects of British society. It is vital to our rural communities, as I know only too well, representing a very rural south-west Wales constituency. It is very much the case that it creates community cohesion. There is a very interesting **Oxford University** report on its importance in tackling loneliness as well. As an example of its diversity and importance, the Pub is The Hub organisation says that the pub now supports a huge range of community services, from adult education classes through to broadband and to local shops, post offices and so on in the community.

Ufi Ibrahim:

In the meantime, if we look at the estimates, for example of the **Migration Observatory** at **Oxford University**, which put the volume of EU migrant workers in our industry at 15%, and extrapolate that back to the 4.5 million people employed in hospitality and tourism, that gives you a figure of around 700,000 people. We think that is very conservative as a number, particularly in areas such as London and the south-east, where the percentage jumps to in excess of 40% as an average. The productivity plan had another tremendous advantage, because it focused our attention not on how much we were spending, but on how quickly we were implementing the projects to which the Government were committed. One of the projects in the plan—it was subsequently raised by the National Infrastructure Commission—that was highly thought of was the **Oxford to Cambridge** corridor, to connect through Milton Keynes and Bedford, and onward to Cambridge. I am pleased that the Department for Transport has heard the message and is now coming forward with new ideas to make that happen sooner than was envisaged even at the time of the productivity plan.

I ask the Minister to pay particular attention to how procedures involving the interaction of Departments can be enhanced. I am talking about the time a proposal spends sitting in the inbox of one part of this complex system of organisations, Departments and agencies that have to approve something before it moves to the outbox and on to the next Department. This applies particularly to aspects of the road highway between **Oxford and Cambridge**, where there is an opportunity to move the timeframe forward. I would be very grateful for the opportunity to talk to the Minister or his counterparts in the Department for Transport about this.

Let me respond to the challenge from the hon. Gentleman. If the Minister believes, as seems to be the case on the basis of what the National Infrastructure Commission has said, that the corridor between **Oxford and Cambridge** is important, he has a responsibility under the principles of the productivity plan to implement the relevant initiatives, plans and

investments as quickly and effectively as possible, and to set a new benchmark for the speed of implementation.
