

## Course Information Sheet for entry in 2024~25

### Undergraduate Certificate in English Literature – option 1

#### About the course

*Please note: this course was previously called the Foundation Certificate in English Literature.*

Covering a range of writing from Shakespeare to the twentieth century, the Undergraduate Certificate in English Literature teaches skills in the analysis of literature, including the ability to read closely and to recognise and apply approaches in contemporary literary theory. Taught part-time over two years, it is equivalent to the first year of a full-time undergraduate English degree. It is modelled on Oxford University's first-year programme in English Language and Literature, and is taught mainly by members of the University's English Faculty.

As well as taking part in the tutorials, seminars, and day schools at Oxford University's Department for Continuing Education, you will have free access to English Faculty lectures and the excellent resources of the Bodleian Library.

The course covers a range of English literature from the Early Modern period to the twentieth century. Among the authors usually studied will be Shakespeare, Marlowe, Donne, Dickens, Tennyson, the Brontës, Hardy, Mansfield, Joyce and Woolf. Close analysis of works by these and other authors, reinforced by general discussion of modern critical theory and practice, and canonicity, will provide the basis for an enhanced appreciation of the pleasures and problems associated with the serious reading of literature. In addition, during year two of the course, students are introduced to the history and varieties of the English language.

The course will consist of three principal elements, each subdivided, to offer a total of six sections over its two-year span. The three elements are:

- i) Approaches to Language and Literature
- ii) Victorian and Modernist Literature
- iii) Early Modern Literature

The course structure can be represented as follows:

Classes usually meet once a week during term-time and there are usually ten classes per term. You will typically have two tutorials per term, with generally no more than two students in each tutorial group.

In addition, there is a summer school of five days' duration between year one and year two, as well as a series of six day schools, usually one per term. Each day school will be linked to the syllabus, usually by its subject matter, though the third will focus on preparation for examinations.

As well as the time spent in teaching sessions, you will need to spend around 12-15 hours a week studying in term-time. This might include reading, preparing course work, and using libraries. Most teaching events and the summer school are usually held in-person, but may be moved online, rescheduled or revised if necessary e.g. as a result of a pandemic.

### **Assessment**

Assessment for the award is through coursework, portfolios and examinations. Candidates are required to submit each of the assessment items below:

#### Year 1

- Two formative assignments, each of not more than 2000 words. Marks for these do not count to the final award.
- Four coursework assignments, each of not more than 2000 words.
- One portfolio of written work demonstrating critical approaches to language and literature, of not more than 3,000 words.
- Two written examinations.

#### Year 2

- Seven coursework assignments, each of not more than 2000 words.
- One portfolio of written work demonstrating critical approaches to language and literature, of not more than 5,000 words.
- Two written examinations.

### **Changes to courses**

The University will seek to deliver this course in accordance with the description set out in this course information sheet. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. ### Fee status

### Information for applicants from the EU, EEA and Switzerland

On 11 May 2021 the UK Council for International Student Affairs published [new regulations and guidance](#) to be used in assessing the fee status of students commencing courses in August 2021 and later. We will be using this guidance to carry out fee status assessments for students commencing courses in 2024~25, including students from the EU, EEA and Switzerland.

If you are an EU national and do not live in the UK then you are likely to be charged Overseas fees. Students with settled and pre-settled status in the UK and some other categories of students who work in the UK can qualify for Home fee status as long as they meet the residence criteria.

### Additional cost information

This course has a study week in Oxford so you will need to meet any travel, accommodation and other costs you may incur in attending this week.

### Living costs

In addition to your fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.

For the 2024~25 academic year, the range of likely living costs for full-time study is between c. £1,345 and £1,995 for each month spent in Oxford. When planning your finances for any future years of study in Oxford beyond 2024~25, you should allow for an estimated increase in living expenses of 5% or more each year, although this rate may vary significantly depending on how the national economic situation develops.

The living costs above are based on single, full-time students living in Oxford. While it may be the case that, as a part-time student, you will not be based in Oxford during your studies, you will still need to cover your cost of living on a full-time basis. If this applies to you, you should calculate your living costs to be sure that you have sufficient funding to meet these costs for the duration of your course. In particular, part-time students who are not based in Oxford will need to calculate travel and accommodation costs carefully. Please note that living costs outside Oxford may be different from those shown above.
