



## Course Information Sheet for entry in 2018-19

### DPhil in Evidence-Based Health Care

#### About the course

The DPhil programme applications from those who have already been awarded the MSc in Evidence-Based Health Care or a master's in a related subject.

The DPhil follows on from the taught MSc in Evidence-Based Health Care (EBHC) and is overseen by the University's Continuing Education Board. Admission is through the Department for Continuing Education.

Supervision is arranged to suit your DPhil topic and usually involves staff staff attached to the Centre for Evidence-Based Medicine. It may also involve other staff from within the Medical Sciences Division as well as co-supervision with members of the Evidence-Based network.

The part-time DPhil is part of the Evidence-Based Health Care Programme, which is jointly run with the Centre for Evidence-Based Medicine in the Nuffield Department of Primary Health Care Sciences. The programme also works closely with the Centres of Evidence-Based Nursing, Evidence-Based Mental Health, and Evidence-Based Dentistry. You have access to the full range of Oxford's library and computing facilities.

The University's DPhil regulations normally require a minimum of four years' part-time study, equivalent to two years' full-time, up to a maximum of eight years part-time study. Research students are required to attend Oxford in person for a minimum of 30 days each year.

If you are a research student you may be required to undertake appropriate research training provided within the department. In addition, you will be strongly encouraged to participate in seminars and informal meetings with staff and other researchers. The major commitment of your time will be to individual study and research.

If you are a research student you are also a member of the University with one of two statuses, depending on the stage of your research - Probationer Research Students (PRS) status, or DPhil student status.

Between each status, you must pass through a milestone assessment. To pass from PRS to DPhil, the milestone is the 'transfer of status'. Before submitting the thesis, you must pass the 'confirmation of status' milestone.

#### Changes to courses

The University will seek to deliver this course in accordance with the description set out above. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. The fees shown above are the annual tuition and college fees for this course for entry in the stated academic year; for courses lasting longer than one year, please be aware that fees will usually increase annually. Tuition and college fees are payable each year for the duration of your fee liability (your fee liability is the length of time for which you are required to pay tuition and college fees).

Graduate students who have reached the end of their standard period of fee liability may be required to pay a termly University and/or a college continuation charge.

The University continuation charge, per term for entry in 2018-19 is £468, please be aware that this will increase annually. For part-time students, the termly charge will be half of the termly rate payable by full-time students.

If a college continuation charge applies (not applicable for non-matriculated courses) it is likely to be in the region of £100 to £400 per term. Please contact your college for more details.

### Additional cost information

Please note that you are required to attend in Oxford for a minimum of 30 days each year, and you may incur additional travel and accommodation expenses for this. Also, depending on your choice of research topic and the research required to complete it, you may incur further additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

## Living costs

In addition to your tuition and college fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.

The likely living costs for 2018-19 are published below. These costs are based on a single, full-time graduate student, with no dependants, living in Oxford. We provide the cost per month so you can multiply up by the number of months you expect to live in Oxford.
