

## Course Information Sheet for entry in 2023-24: MPhil in Politics (European Politics and Society)



### About the course

The MPhil in Politics (European Politics and Society) is an advanced two-year graduate degree which provides training in research techniques and methodology and enables you to acquire substantive knowledge in this sub-area of the discipline. It is also suitable if you later wish to embark upon doctoral research.

The MPhil in Politics (European Politics and Society) is taught by a group of scholars who specialise in all aspects of European politics, including European integration, comparative European government, Europe's external relations and the political systems of individual European countries.

The MPhil offers the opportunity to engage with scholars and practitioners from various European countries and institutions, and will provide you with a solid foundation for a wide range of careers, including academic, professional, commercial, diplomatic and governmental positions.

The approach to teaching comprises intensive and interactive work between you and your supervisor and course teachers, combined with a carefully planned programme of classes, seminars and lectures, as well as directed self-study.

In the first year, you must complete core classes and tutorials in European Governance and a programme of research methods training, which includes core courses in statistics and research design and specialised elective courses.

In your second year, you must write a thesis and complete two specialist optional papers. Options that have been offered in recent years include:

- The Political Sociology of Post-Communist Societies
- Comparative Political Economy of Advanced Democracies
- EU Foreign Policy
- Protest, Social Movements and Revolution

### Supervision

The allocation of graduate supervision for this course is the responsibility of the Department of Politics and International Relations and it is not always possible to accommodate the preferences of incoming graduate students to work with a particular member of staff. Supervisors are usually selected from the academic staff within the Department of Politics and International Relations. Under exceptional circumstances a supervisor may be found outside the Department of Politics and International Relations. Students can expect to meet with their supervisor approximately three times each term.

### Assessment

At the end of your first year, you will sit a written examination in the core subject, submit a research design proposal as preparation for the MPhil thesis, and successfully pass four research methods assessments.

Progression to the second year is conditional on passing all the first year assessments.

At the end of the course, you are required to sit written examinations in the two optional papers of your choice and submit a thesis.

### Changes to courses

The University will seek to deliver this course in accordance with the description set out above. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. These may include significant changes made necessary by a pandemic (including Covid-19), epidemic or local health emergency. ### Information about course fees

### Additional cost information

There are no compulsory elements of this course that entail additional costs beyond fees and living costs. However, as part of your course requirements, you may need to choose a dissertation, a project or a thesis topic. Please note that, depending on your choice of topic and the research required to complete it, you may incur additional expenses, such as travel and vaccination expenses, conference attendance, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

## Living costs
