About the course

The MPhil in Politics (Political Theory) is an advanced graduate degree providing training in research techniques and methodology, enabling you to acquire substantive knowledge in this sub-area of the discipline.

The MPhil in Politics (Political Theory) is a standalone degree but it is also suitable for those intending to embark upon doctoral research in the future.

Many of the academic staff who teach and supervise on the programme also organise extracurricular research seminars for graduate students, such as the Oxford Political Thought Seminar and the Nuffield Political Theory Workshop, which takes place throughout term.

The Department of Politics and International Relations (DPIR) also hosts a wide range of research centres and programmes which actively seek to develop collaborative research activity via conferences, workshops and other academic events, and which include graduate students in their activities.

Research centres provide opportunities for you to present your own work in research seminar series and at conferences in the department and beyond. The research centres have an established and popular visitors' programme which has allowed many scholars of international repute to participate in the DPIR's research activities.

Course structure

An overview of the course structure is provided below. Details of the compulsory and optional elements of the course are provided in the *Course components* section of this page.

In your first-year you will complete core classes and tutorials, as well as compulsory research methods training. This is supplemented in the second year by two optional subjects and a thesis.

The approach to teaching comprises intensive and interactive work between you and your supervisor and course teachers, combined with a carefully planned programme of classes, seminars and lectures, as well as directed self-study.

Work on the thesis is individually supervised.

Attendance

The course is full-time and requires attendance in Oxford. Full-time students are subject to the <u>University's Residence requirements</u>. (//www.ox.ac.uk/admissions/graduate/after-you-apply/accommodation/residence-requirements)

Resources to support your study

As a graduate student, you will have access to the University's wide range of resources including libraries, museums, galleries, digital resources and IT services.

The Bodleian Libraries is the largest library system in the UK. It includes the main Bodleian Library and libraries across Oxford, including major research libraries and faculty, department and institute libraries. Together, the Libraries hold more than 13 million printed items, provide access to e-journals, and contain outstanding special collections including rare books and manuscripts, classical papyri, maps, music, art and printed ephemera.

The University's IT Services is available to all students to support with core university IT systems and tools, as well as many other services and facilities. IT Services also offers a range of IT learning courses for students to support with learning and research, as well as guidance on what technology to bring with you as a new student (https://www.it.ox.ac.uk/what-to-bring) at Oxford.

The <u>Bodleian Social Science Library (https://www.bodleian.ox.ac.uk/libraries/ssl)</u> located on the ground floor of the Manor Road Building houses the main collection for Politics and International Relations alongside a wide range of other social sciences resources.

The <u>Politics and International Relations subject guide (https://libguides.bodleian.ox.ac.uk/politics)</u> provides up-to-date advice and the contact details of your Subject Librarian for further support.

Supervision

The allocation of graduate supervision for this course is the responsibility of the Department of Politics and International Relations and it is not always possible to accommodate the preferences of incoming graduate students to work with a particular member of staff. Supervisors are usually selected from the <u>academic staff (https://www.politics.ox.ac.uk/dpir-academics-and-researchers)</u> within the Department of Politics and International Relations. Under exceptional circumstances a supervisor may be found outside the Department of Politics and International Relations.

Students can expect to meet with their supervisor around three times each term.

Assessment

Progression to the second year is conditional on passing examinations and/or coursework in research methods as well as the core course.

At the end of the course, you will complete two option papers of your choice assessed by examination or coursework and submit a thesis.

Course components

Compulsory Study

You will take core classes and tutorials in the theory of politics.

Courses in approaches to the study of political theory, reasoning in contemporary political philosophy, and problems of method in the history of political thought, form the basis of the core component in research methods training.

You will write a thesis in your second year.

Options

You will complete two specialist option papers. Options offered in recent years have included:

- · Imperialism in 20th Century Political Thought
- Political Theories of Hegel and Marx
- · Mitigating Historical Injustice
- Feminism and the Future
- Contemporary Political Philosophy
- Normative Political Economy: The Ethics of Economic Systems and Social Policy
- Reasonable Disagreement and Political Argument.

Changes to this course

The University will seek to deliver this course in accordance with the description set out in this course page. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. What do course fees cover?

How long do I need to pay course fees?

Course fees are payable each year, for the duration of your fee liability (your fee liability is the length of time for which you are required to pay course fees). Additional costs

There are no compulsory elements of this course that entail additional costs beyond fees and living costs. However, as part of your course requirements, you may need to choose a dissertation, a project or a thesis topic. Please note that, depending on your choice of topic and the research required to complete it, you may incur additional expenses, such as travel and vaccination expenses, conference attendance, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department to help you cover some of these expenses.

Living costs

In addition to your course fees and any additional course-specific costs, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.

Living costs for full-time study

For the 2026-27 academic year, the range of likely living costs for a single, full-time student is between £1,405 and £2,105 for each month spent in Oxford. We provide the cost per month so you can multiply up by the number of months you expect to live in Oxford. Depending on your circumstances, you may also need to budget for the costs of a student visa and immigration health surcharge (//www.ox.ac.uk/admissions/graduate/fees-and-funding/living-costs) and/or living costs for family members or other dependants (//www.ox.ac.uk/admissions/graduate/fees-and-funding/living-costs#field_listing_content_content-item--2) that you plan to bring with you to Oxford (if dependant visa eligibility criteria (//www.ox.ac.uk/students/visa/before/family) are met).

Further information about living costs

The current economic climate and periods of high national inflation in recent years make it harder to estimate potential changes to the cost of living over the next few years. For study in Oxford beyond the 2026-27 academic year, it is suggested that you budget for potential increases in living expenses of around 4% each year – although this rate may vary depending on the national economic situation.

A breakdown of likely living costs for one month during the 2026-27 academic year are shown below. These costs are based on a single, full-time graduate student, with no dependants, living in Oxford.
