DPhil in History of Art

About the course

This is an advanced research degree, granted on successful completion and defence of an individual research thesis. The programme is usually undertaken on a full-time basis, but the faculty is also able to offer the programme in a part-time mode of attendance.

The DPhil in History of Art is an advanced research degree, awarded on the basis of a thesis and an oral examination. The thesis will be based on extensive original research and engagement with current scholarship. Full-time DPhil students are expected to submit their thesis three, or at most four, years from the date of admission. Part-time DPhil students are expected to submit their thesis six, or at most eight years from the date of admission.

All students for the DPhil in History of Art will be supported by a supervisor or supervisors who will help them develop a programme of research and writing. You will also benefit from the advice and support of other members of the department who will be involved in the progression of students through the transfer and confirmation stages of the degree, and can draw on the expertise of scholars and colleagues throughout the faculty and University.

All DPhil students are expected to attend and to contribute to the wide range of research seminars, conferences and workshops organised by the department and faculty. You also have access to specialist training courses offered by the Bodleian Library and IT services.

Part-time students are fully integrated into the research culture of the university and are expected to attend the University on a regular basis for supervision, study, skills training and participation in some of the many research seminars. If you are in employment, you must provide a letter from your employer agreeing to adjust your working hours in order to facilitate attendance at the University as required for the duration of the course.

The department appreciates that part-time research students will have non-standard attendance and work patterns but applicants must understand that this is not a distance-learning degree programme. Your supervisor and the co-ordinator of part-time studies, currently the Regius Professor of History, are available to advise part-time students on access to research and training provision.

Please note that it is not possible to change from full-time to part-time study, or vice-versa, once enrolled.

Changes to courses

The University will seek to deliver each course in accordance with the descriptions set out above. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. The fees shown above are the annual tuition and college fees for this course for entry in the 2016-17 academic year; for courses lasting longer than one year, please be aware that fees will usually increase annually. For details, please see our guidance on likely increases to fees and charges.

Tuition and college fees are payable each year for the duration of your fee liability (your fee liability is the length of time for which you are required to pay tuition and college fees).

Graduate students who have reached the end of their standard period of fee liability may be required to pay a termly University and/or college continuation charge.

The University continuation charge, per term for entry in 2016/17, is currently £440, please be aware that this will increase annually.

For part-time students, the termly charge will be half of the termly rate payable by full-time students.

If a college continuation charge applies (not applicable to non-matriculated courses) it is likely to be in the region of £100 to £400 per term. Please contact your college for more details.

Additional cost information

Full-time study

There are no compulsory elements of this programme that entail additional costs beyond fees and living costs. However, please note that, depending on your choice of research topic and the research required to complete it, you may incur additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

Part-time study

Please note that you are required to attend in Oxford for a minimum of 30 days each year, and you may incur additional travel and accommodation expenses for this. Also, depending on your choice of research topic and the research required to complete it, you may incur further additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

Living costs

In addition to your fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.

The likely living costs for 2016-17 are published below. These costs are based on a single, full-time graduate student, with no dependants, living in Oxford. We provide the cost per month so you can multiply up by the number of months you expect to live in Oxford.
