#### **MSt in Diplomatic Studies**

#### About the course

The MSt in Diplomatic Studies is a progression course and available only if you have already completed the PGDip in Diplomatic Studies. You will transfer from the Certificate in Diplomatic Studies to the PGDip in Diplomatic Studies at the end of your first term. If you successfully complete the Postgraduate Diploma then you may progress to the MSt, a distance learning course, during a second academic year.

The MSt consists of an academic year of research (undertaken part-time) and the writing of a 15,000-word dissertation under distance supervision. The dissertation will be on a topic relevant to one or more of the subjects covered in the PGDip course year.

The working language of the course is English.

able to apply for small grants from your department and/or college to help you cover some of these expenses.
