General Information

These are the tuition fee rates for the academic year 2010/11. Tuition fees do not include college fees, accommodation, or other course and maintenance fees unless otherwise indicated in the notes field.

The rates listed are for one academic year, 2010/11. You should expect to pay tuition fees for every year you are in attendance and be aware these fees will increase annually. Some qualifications have a maximum period of University tuition fee liability. Fee rates are split into three residency categories: Home/EU, Islands* and Overseas.

If you have previously studied at graduate level (e.g. you are returning to study a second Masters degree) you may be liable to pay the higher ELQ fee given in the fee lists. There is no separate ELQ fee for modular courses.

All courses listed are part-time unless otherwise stated. Details of fees for OU DCE DPhil programmes can be found in the Graduate Research programme lists.

Charging Structure

There are two charging structures for programmes of study (courses) run by the Department for Continuing Education:

Modular - Students on these programmes of study pay a fee for each module they attend in addition to an annual programme fee. For all modular courses, the annual programme fee includes the college fee. Two programmes in the Mathematical, Physical and Life Sciences Division (MPLS) also charge fees on a modular basis. These fees are given in these lists.

Annual - Students on these programmes of study pay a fee for every year they are in attendance.

Note that certain Masters courses are only available by progression from other Oxford University courses. Students on these programmes of study are required to complete a postgraduate certificate and/or diploma before they can progress to the Masters qualification. An estimate of the fee cost for the entire period of study leading to the Masters degree is given.

College fees

College fees are usually only payable by students registered for Master's and DPhil degrees. Please check with your college office for full details on any college fees you are due to pay

* Island rates, which are only payable by students from Channel Islands and Isle of Man, apply to undergraduate programmes of study and the PGCE only. For all other programmes Islands students are charged at the Home/EU rate.
