DPhil in Management

About the course

The University of Oxford's doctoral programme in management at Saïd Business School offers high-calibre researchers the chance to work closely with faculty at the forefront of their fields, to be part of a vibrant research community and to benefit from the resources and reputation of the University.

Saïd Business School is a young school in an ancient university, but it has already generated outstanding research strengths and the DPhil, which is also known as a PhD, offers students the opportunity to engage with internationally renowned faculty and access specialist research centers and facilities.

The DPhil in Management is built on coursework and research in specialisms such as accounting, marketing, management science, organisational behaviour, strategy, international business, entrepreneurship and innovation. The programme focuses on using both quantitative and qualitative methods. Required core courses taken by all students are:

- Statistical Research Methods
- Introduction to Management Research Methods
- Management and Organisation Theory

Students will additionally attend either one or two Advanced Research Methods courses and two or three specialist electives. Information about current DPhil projects and faculty areas of interest can be found on the school's website.

Supervision

For this course, the allocation of graduate supervision is the responsibility of Saïd Business School and it is not always possible to accommodate the preferences of incoming graduate students to work with a particular member of staff. Under exceptional circumstances a supervisor may be found outside the Saïd Business School.

Each student normally has two supervisors. Supervisors oversee students' study and research as well as advise them on the preparation of their thesis through regular meetings. Supervisors and students should work together to establish mutually convenient regular meeting times.

Assessment

All students will be initially admitted to the status of Probationer Research Student (PRS). Normally by the fourth term students will be expected to apply for and achieve transfer of status from Probationer Research Student to DPhil status.

A successful transfer of status from PRS to DPhil status will require students to have passed the appropriate assessment requirements and a substantial piece of written work relevant to the proposed thesis as specified in the Course Handbook. Students who are successful at transfer will also be expected to apply for and gain confirmation of DPhil status within nine terms of admission, to show that their work continues to be on track.

Both milestones normally involve an interview with two assessors (other than the candidate's supervisor(s)) and will provide important experience for the final oral examination.

Students will be expected to submit a thesis which provides a substantial contribution to management research, which should not exceed 100,000 words, usually within four years from the date of admission. To be successfully awarded a DPhil in Management, students will need to defend their thesis orally (viva voce) in front of two appointed examiners.

Students may choose from a range of methodologies and approaches, but their contribution in the field of theory, methodology or in terms of your empirical results should be relevant enough to be published as a book, or as a series of academic articles. Students can choose to submit a single monograph or integrated thesis (a hybrid of conventional chapters and papers, or fully article-based).

Changes to courses

The University will seek to deliver this course in accordance with the description set out above. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. These may include significant changes made necessary by a pandemic (including Covid-19), epidemic or local health emergency.

Information about course fees

Course fees are payable each year, for the duration of your fee liability (your fee liability is the length of time for which you are required to pay course fees). For courses lasting longer than one year, please be aware that fees will usually increase annually. Course fees cover your teaching as well as other academic services and facilities provided to support your studies. Unless specified in the additional cost information (below), course fees do not cover your accommodation, residential costs or other living costs. They also don't cover any additional costs and charges that are outlined in the additional cost information.

Graduate students who have reached the end of their standard period of fee liability may be required to pay a termly University and/or a college continuation charge.

The University continuation charge, per term for entry in 2023-24 is £572, please be aware that this will increase annually. For part-time students, the termly charge will be half of the termly rate payable by full-time students.

If a college continuation charge applies (not applicable for non-matriculated courses) it is likely to be in the region of £100 to £600 per term. Please contact your college for more details.

Additional cost information

There are no compulsory elements of this course that entail additional costs beyond fees (or, after fee liability ends, continuation charges) and living costs. However, please note that, depending on your choice of research topic and the research required to complete it, you may incur additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

Living costs

In addition to your course fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.

If you are studying part-time your living costs may vary depending on your personal circumstances but you must still ensure that you will have sufficient funding to meet these costs for the duration of your course.
