# Course Information Sheet for entry in 2019-20 DPhil in Physiology, Anatomy and Genetics



#### About the course

The DPhil in Physiology, Anatomy and Genetics provides students with a wide range of research topics within a large multi-disciplinary and world-renowned department, spanning a diverse spectrum of research areas from neuroscience, cardiac science, ion channels transporters and signalling, metabolism and endocrinology, development and reproduction to functional genomics.

You are strongly advised to visit the DPAG website and Medical Sciences Graduate School website to help you identify the most suitable course and supervisors.

Your research will be conducted at Oxford under the supervision of academic staff who are at the forefront of developments in your chosen research project area. You will explore your research subject area to new depths and have the opportunity to present your findings to members of the international scientific community with whom, one day, you may collaborate with.

At the end of your study you will produce a doctoral thesis that represents a significant advance in the field. You will have become a world expert in your research area, and you will have demonstrated that you are an original and creative thinker capable of independent scientific work at a very high level.

You will have access to regular departmental seminars, skills and training courses, peer presentation groups for fine tuning presentation deliverance and graduate student social events that incorporate informal talks aimed at students.

You will be encouraged to submit termly reports on your progress and report courses undertaken. The supervisor will also contribute to the termly reports. When achieved, the key milestones of a DPhil will eventually result in the awarding of the Doctor of Philosophy title.

Tuition and college fees are payable each year for the duration of your fee liability (your fee liability is the length of time for which you are required to pay tuition and college fees).

Graduate students who have reached the end of their standard period of fee liability may be required to pay a termly University and/or a college continuation charge.

The University continuation charge, per term for entry in 2019-20 is £488, please be aware that this will increase annually. For part-time students, the termly charge will be half of the termly rate payable by full-time students.

If a college continuation charge applies (not applicable for non-matriculated courses) it is likely to be in the region of £100 to £400 per term. Please contact your college for more details.

## Additional cost information

There are no compulsory elements of this course that entail additional costs beyond fees (or, after fee liability ends, continuation charges) and living costs. However, please note that, depending on your choice of research topic and the research required to complete it, you may incur additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

## Living costs

In addition to your tuition and college fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.
