MPhil in Music (Performance)

About the course

The MPhil is designed for students wishing to attain a thorough grounding in musical performance studies at an advanced level, either as a preparation for doctoral research or an autonomous qualification. In the first year you will follow the MSt in Music (Performance), proceeding in the second year to individual supervision leading to the completion of a recital and a dissertation.

The Master of Philosophy in Music (Performance) introduces a broad range of current methodologies and approaches in music scholarship.

The first year of the course is identical to that of the MSt in Music (Performance).

In order to proceed to the second year of the MPhil, you will normally need to obtain an average of 65% for your first year work overall, and a mark of over 70 in your final recital.

The second year is then spent producing coursework, comprising both a recital of 45 minutes duration of at least two contrasted pieces, and a dissertation of between 17,000 and 19,000 words in musicology or ethnomusicology or a substantial edition with prefatory matter of comparable length.

Supervision

The allocation of graduate supervision for this course is the responsibility of the Faculty of Music and it is not always possible to accommodate the preferences of incoming graduate students to work with a particular member of staff. Under exceptional circumstances a supervisor may be found outside the Faculty of Music.

Changes to courses

The University will seek to deliver this course in accordance with the description set out above. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. Course fees are payable each year, for the duration of your fee liability (your fee liability is the length of time for which you are required to pay course fees). Course fees cover your teaching as well as other academic services and facilities provided to support your studies. They also don't cover any additional costs and charges that are outlined in the additional cost information.

Additional cost information

There are no compulsory elements of this course that entail additional costs beyond fees and living costs. However, as part of your course requirements, you may need to choose a dissertation, a project or a thesis topic. Please note that, depending on your choice of topic and the research required to complete it, you may incur additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses. For Music (Performance), the faculty provides funding to support performance tuition which is normally sufficient to meet costs in this area.

Living costs

In addition to your course fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.

The likely living costs for 2020-21 are published below. These costs are based on a single, full-time graduate student, with no dependants, living in Oxford. We provide the cost per month so you can multiply up by the number of months you expect to live in Oxford.
