

## Course Information Sheet for entry in 2022-23: MSc by Research in Information, Communication and the Social Sciences



### About the course

The MSc by Research (MSc(Res)) programme in Information, Communication and the Social Sciences provides an opportunity for highly-qualified students to undertake innovative Internet-related research.

The Oxford Internet Institute's (OII) students work on multidisciplinary research across the social sciences. Many projects fit within the following broad themes:

- digital knowledge and culture
- digital politics and government
- education, wellbeing and digital life
- ethics and philosophy of information
- information geography and inequality
- digital policy and online security
- economics of information and the Internet
- online platforms and social networks.

Over the course of this one to three-year programme, students produce an original piece of scholarship that will make a novel contribution to the dynamic area of Internet research. OII MSc (Res) graduates have the qualities and transferable skills necessary to excel in teaching, research, policymaking or business.

The MSc (Res) in Information, Communication and the Social Sciences is normally only offered for graduates of either the MSc in Social Science of the Internet or MSc in Social Data Science who apply to extend their work at OII with an independent, research-focused project.

MSc (Res) students at the OII address research questions from across a spectrum of disciplines. OII MSc (Res) students anchor their research in disciplinary questions (in, for instance, politics or sociology), while also situating their research in broader social science theories and methods. OII faculty are international leaders in their research fields, and their teaching and supervision reflect their innovative research. MSc (Res) students study alongside a diverse cohort of doctoral students, which complements the strength of the programme by providing a multidisciplinary peer network for students to engage in ideas, discussion and debate.

### Supervision

The allocation of graduate supervision for this course is the responsibility of the Oxford Internet Institute and it is not always possible to accommodate the preferences of incoming graduate students to work with a particular member of staff. Please see the full list of faculty members eligible to supervise MSc (Res) students for this programme. Under exceptional circumstances a supervisor may be found outside the Oxford Internet Institute.

### Assessment

Students will first be registered as a Probationer Research Student (PRS) and must normally achieve 'transfer' to the status of a MSc (Res) student by the end of their third term (or fourth term at the latest). A successful transfer from PRS to MSc (Res) status will require satisfactory completion of such lectures, seminars and classes (with a mark of 50 or higher) as the Graduate Studies Committee of the OII shall determine.. The purpose of the transfer is to ensure that the student has a viable research proposal and that they are making satisfactory progress in its development, and to satisfy the assessors that the work is potentially of MSc (Res) quality.

MSc (Res) students will be expected to submit an original thesis of not more than 25,000 words. To be successfully awarded the degree of Master of Science by Research in Information, Communication and the Social Sciences you will be required to defend your thesis orally (viva voce) in front of two appointed examiners.

### Changes to courses

The University will seek to deliver this course in accordance with the description set out above. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. These may include significant changes made necessary by a pandemic (including Covid-19), epidemic or local health emergency. For

Course fees are payable each year, for the duration of your fee liability (your fee liability is the length of time for which you are required to pay course fees). For courses lasting longer than one year, please be aware that fees will usually increase annually. Information about how much fees and other costs may increase is set out in the University's Terms and Conditions (<http://www.graduate.ox.ac.uk/terms>).

Course fees cover your teaching as well as other academic services and facilities provided to support your studies. Unless specified in the additional cost information (below), course fees do not cover your accommodation, residential costs or other living costs. They also don't cover any additional costs and charges that are outlined in the additional cost information.

Graduate students who have reached the end of their standard period of fee liability may be required to pay a termly University and/or a college continuation charge.

The University continuation charge, per term for entry in 2022-23 is £548, please be aware that this will increase annually. For part-time students, the termly charge will be half of the termly rate payable by full-time students.

If a college continuation charge applies (not applicable for non-matriculated courses) it is likely to be in the region of £100 to £600 per term. Please contact your college for more details.

### Additional cost information

There are no compulsory elements of this course that entail additional costs beyond fees (or, after fee liability ends, continuation charges) and living costs. However, please note that, depending on your choice of research topic and the research required to complete it, you may incur additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

## Living costs

In addition to your course fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.

If you are studying part-time your living costs may vary depending on your personal circumstances but you must still ensure that you will have sufficient funding to meet these costs for the duration of your course.

The likely living costs for 2022-23 are published below. These costs are based on a single, full-time graduate student, with no dependants, living in Oxford. We provide the cost per month so you can multiply up by the number of months you expect to live in Oxford.
