### **MSc by Research in Pharmacology**

#### **About the course**

The MSc by Research in Pharmacology offers a very wide range of topics from calcium signalling to cardiovascular pharmacology and neuropharmacology.

Applicants are strongly advised to visit the Medical Sciences Graduate School website to help them identify the most suitable course and supervisors.

On the MSc by Research programme your research will be carried out at Oxford under the supervision of a member of academic staff. You will work within their research group on a project at the forefront of the subject, and at the end of your time with us you will produce a thesis that represents a significant advance in the field. You will become the world expert in your research area and you will have demonstrated that you are an original and creative thinker capable of independent scientific work at a very high level.

If you are interested in joining the department as a MSc by Research research student, you are strongly encouraged to look at the department's research pages to identify areas of research that interest you.

Selecting the correct research project is a hugely important first step, so it is recommended that you contact potential supervisors directly to discuss possibilities before you apply online.

On starting as a probationary research student, besides regular monitoring undertaken by your supervisor and department the University also checks your progress at your transfer to MSc status.

Course fees cover your teaching as well as other academic services and facilities provided to support your studies. Unless specified in the additional information section below, course fees do not cover your accommodation, residential costs or other living costs. They also don't cover any additional costs and charges that are outlined in the additional cost information below.

Course fees are payable each year, for the duration of your fee liability (your fee liability is the length of time for which you are required to pay course fees). For courses lasting longer than one year, please be aware that fees will usually increase annually. For details, please see our guidance on likely increases to fees and charges.

Graduate students who have reached the end of their standard period of fee liability may be required to pay a termly University and/or a college continuation charge.

The University continuation charge, per term for entry in 2019-20 is £488, please be aware that this will increase annually. For part-time students, the termly charge will be half of the termly rate payable by full-time students.

If a college continuation charge applies (not applicable for non-matriculated courses) it is likely to be in the region of £100 to £400 per term. Please contact your college for more details.

### Additional cost information

There are no compulsory elements of this course that entail additional costs beyond fees (or, after fee liability ends, continuation charges) and living costs. However, as part of your course requirements, you may need to choose a dissertation, a project or a thesis topic. Please note that, depending on your choice of topic and the research required to complete it, you may incur additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

## Living costs

In addition to your course fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.

The likely living costs for 2019-20 are published below. These costs are based on a single, full-time graduate student, with no dependants, living in Oxford. We provide the cost per month so you can multiply up by the number of months you expect to live in Oxford.
