

Course Information Sheet for entry in 2021-22: MSt in Late Antique and Byzantine Studies



About the course

The MSt in Late Antique and Byzantine Studies has been devised as a multi-purpose introduction to the Roman world in Late Antiquity, to Byzantium, the medieval successor of the East Roman Empire, and to neighbouring peoples and their cultures.

This is a nine-month taught course that can be taken as a free-standing degree, or as the first step towards doctoral research.

Course structure

You have the option of selecting a focus of study dependant on your knowledge of languages or on your primary interests in the field. Two basic pathways lead into each field of study, and you are expected to choose between them at the beginning of the course.

Pathway one

The first is the language training pathway, which offers intensive training in any one of the following ancient and medieval languages:

- Greek
- Latin
- Slavonic
- Armenian
- Syriac
- Coptic
- Arabic.

In the first two academic terms you will take a core paper on history, art and archaeology or history and Byzantine literature comprising two sets of weekly classes. You will also take intensive courses in both language and literature.

Pathway two

The second pathway, is designed for those who already have considerable competence in their chosen language and are able to read primary sources. You will receive instruction in one or two of a range of specialist auxiliary disciplines of papyrology, epigraphy, palaeography, numismatics, sigillography or artefact studies and you will choose a special subject from a list in your preferred subject area, ie in either history, art and archaeology, literature or religion.

In the first two academic terms for all students, you will take a core paper on history, art and archaeology or history and Byzantine literature comprising two sets of weekly classes. You will also receive instruction in one or two auxiliary disciplines and also in a special subject 10,000-word dissertation on a topic of your choosing, subject to the approval of your supervisor

Assessment

Pathway one

The core paper will be examined on the basis of two 5,000-word essays on topics of your choosing, subject to the approval of your supervisor, submitted in Hilary and at the end of Trinity term. The intensive courses in language and literature will be assessed by examinations at the end of the year.

Pathway two

The core paper will be examined on the basis of two 5,000-word essays on topics of your choosing, subject to the approval of your supervisor, submitted in Hilary and at the end of Trinity term. Auxiliary disciplines will normally be examined by unseen examinations and you will also be assessed on your dissertation which will be submitted at the end of Trinity term.

Please note that not every optional subject listed may be on offer every year, depending in part on levels of student demand. Full details of core and optional papers available are available on the course webpage.

Although the two components of the course, Late Antiquity and Byzantium, have been designed to the same specification and are conjoined in a single course, you are expected to concentrate on one or other of the fields. If you wish to proceed to a research

programme you will be encouraged to develop your doctoral proposal during the first few months of the programme, so that you will be well placed to make a doctoral application.

You should not apply to both the MSt and MPhil in this research area. Both courses have the same entry requirements.

Supervision

The allocation of graduate supervision for this course is the responsibility of the Faculty of History and it is not always possible to accommodate the preferences of incoming graduate students to work with a particular member of staff. Under some circumstances a supervisor outside the Faculty of History may be nominated.

An Oxford academic's pre-application indication of willingness to supervise an enquiring applicant is not a guarantee that the applicant will be offered a place, or that the supervisor in question has capacity in that particular year.

Changes to courses

The University will seek to deliver this course in accordance with the description set out above. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. These may include significant changes made necessary by a pandemic (including Covid-19), epidemic or local health emergency. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

Living costs

In addition to your course fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.
