# Course Information Sheet for entry in 2021-22: MSt in Study of Religions



#### About the course

This course offers an intensive training in research in the study of religions. It enables you to study two major religions, and to explore the nature of religion itself, at an advanced level. You can select your special subjects from the following five religious traditions currently covered by the faculty: Buddhism, Christianity, Hinduism, Islam and Judaism.

In many cases, you will study the early doctrines and practices of religious traditions in their historical contexts, engaging with primary source texts in English translation, but you may also opt to study the modern variations of a particular religion, or a set of religious practices or institutions in the contemporary world. The Oxford tutorial system applies to postgraduate study in this course, so you are encouraged to develop your particular interests in conversation with your tutors.

Each of these traditions has an internationally-recognised research centre, institute or outstanding cluster of scholars in Oxford. This typically means that you are not only taught by specialists in your chosen tradition, but also have access to a variety of specialist libraries and collections.

#### **Supervision**

The allocation of graduate supervision for this course is the responsibility of the Faculty of Theology and Religion and it is not always possible to accommodate the preferences of incoming graduate students to work with a particular member of staff. Under exceptional circumstances a supervisor may be found outside the Faculty of Theology and Religion.

#### Assessment

You will take a three-hour exam on the core course Methods and Study of Religion/Themes in the Interaction Between Religions.

Your two chosen religions will be examined by two papers, of which one will consist of two essays of up to 5,000 words and one will consist of a dissertation of 10,000–15,000 words. Between them, essays and dissertations must deal with the two chosen religions only. Essays and dissertations on the interactions, relations or comparisons between the two religions, or approaches taken from one view towards the other, are also encouraged, with the proviso that there is no overlap between essays and dissertation.

Finally, you will take an oral examination (viva voce) on your dissertation and essay research topics and wider knowledge of the study of religion if required by the examiners.

The choice of essay and dissertation topics will be decided by the you, subject to advice from your supervisor and final approval. Students are encouraged to use the work on their essays as building blocks towards their dissertation.

#### Changes to courses

The University will seek to deliver this course in accordance with the description set out above. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. These may include significant changes made necessary by a pandemic (including Covid-19), epidemic or local health emergency. #### Additional cost information

There are no compulsory elements of this course that entail additional costs beyond fees and living costs. However, as part of your course requirements, you may need to choose a dissertation, a project or a thesis topic. Please note that, depending on your choice of topic and the research required to complete it, you may incur additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

#### Living costs

In addition to your course fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.

The likely living costs for 2021-22 are published below. These costs are based on a single, full-time graduate student, with no dependants, living in Oxford. We provide the cost per month so you can multiply up by the number of months you expect to live in Oxford.
